To this end I hope to organise a more formal arrangement with our major accrediting bodies the API and RICS and to facilitate annual meetings with senior academics from all accredited universities as a formal part of the PRRES Conference. Leading up to the conference I will be contacting all accredited universities asking that they contribute to this annual discussion on the future of property education.

Book release:

Retrofitting Cities for Tomorrow's World

Edited. Malcolm Eames, Tim Dixon, Miriam Hunt and Simon Lannon. 2108 Wiley Blackwell, London.

Review Sara J Wilkinson.

This book is the culmination of a 4-year collaborative research project undertaken by leading UK universities, city authorities, leading architecture practices and major international property consultancies. *Retrofitting Cities for Tomorrow's World* examines theoretical and practical aspects of the much-needed transition to sustainability. With an emphasis on innovation and new ways of re-imagining urban retrofitting, the book is set within a 'futures based' thinking concept.

Urban retrofitting at city and building scale is gaining prominence in research and policy areas. Whilst cities are a source of resource depletion and stress, they are also hubs of innovation and knowledge offering great potential for scaling up technological responses. However, this requires a major shift in thinking and expanding of positive responses to climate change and associated threats to liveability and resilience. Contributors to the book posit solutions and innovative ideas at building and city scale for ways in which we might retrofit for tomorrows world. The 15-chapter book covers;

1. Governance And Dynamics Of Urban Retrofit
2. Modelling Urban Transitions And Pathways
3. Steering and navigating Sustainable Urban Transitions.

Three of the 15 chapters were written by academics outside the UK. One chapter is

authored by a Dutch academic, Derk Loorbach and two chapters focus on Australian cities, and are written by Australian academics. The chapter co-authored by Sara Wilkinson, Paul van der Kallen, Allan Teale and Hera Antoniadou of UTS focusses on the economic, social and environmental aspects and potential transformation of the commercial property market through green roof retrofit. Peter Newton of Swinburne Uni considers ways of accommodating rapid population growth in our cities through regeneration and retrofit. The other 12 chapters offer insights into how the problems and issues are, or can be tackled outside of Australia, all provide food for thought.
