PRRES Members' achievements

PRRES members in top 2% of researchers in finance

PRRES members, Professor Chau Kwong Wing (Hong Kong University) and Professor Graeme Newell (Western Sydney University) have been included in the top 2% of researchers globally in the finance discipline for impactful research (based on total citations of their research). This is from a major study by researchers at Stanford University, USA, across all disciplines. Property is seen as part of finance in this study. Only seven researchers in finance in each of Australia and Hong Kong were included in this global top 2% list.

This further reinforces the need for PRRES members to focus on the impact of their research; both from an academic and industry perspective. Research impact metrics are becoming increasingly important for promotion etc, so it needs to be prioritised in your academic career planning. See Newell et al (2022), "The significance of impact in real estate research publications", Journal of Property Investment and Finance, Vol. 40 No. 1, pp. 49-67 for a fuller profiling of impactful property researchers globally.

Congratulations to Associate Professor Georgia Warren-Myers and Associate Professor Lucy Cradduck on winning the IVSC-WAVO Global Valuation Conference 2023 Best Paper Award for their paper "Barriers and Facilitators: Valuation processes in a state of climate change".
