# The Forth International Feasibility Competition- Reminder

The International Feasibility competition gives students a chance to demonstrate their skills in property and feasibility analysis through creating a 'Mock Project'. As part of the competition, teams will be provided with project brief, key assumption, site location,

basic planning and market information. It will be up to teams to create the mock development project and present their feasibility, assumptions and recommendations in report for selection to the short list. These exercises will offer opportunities to improve analytical, teamwork, communication and presentation skills. The students also use Estate Master DF software to conduct initial and detailed financial feasibility analysis.

#### New book release

Instruments of Planning: Tensions and Challenges for More Equitable and Sustainable Cities (Routledge, New York, 2016)

Rebecca Leshinsky and Crystal Legacy (Editors) have recently released Instruments Planning, which is a compilation of national and international case studies from different neoliberal settings. This book reflects the opportunities limits for planning instruments in an era where urbanisation is on the increase and land is scarce. Whilst the book takes a critical perspective on the use of planning instruments, it showcases that planning instruments do matter. This is well highlighted through the use of real case studies to show how tools are applied in highly political and emotive environments, often result in unintended undesirable social outcomes. The book is the starting place for a (re)newed approach to planning instruments as innovative and inclusive change agents. The planning industry in Victoria, as well as policy professionals and land use and development academics will benefit greatly from a read of the case studies presented in the book. Instruments of Planning: Tensions and Challenges for More Equitable and Sustainable Cities is a timely contribution to the Victorian and broader national planning landscape.

# University Of Technology Sydney The School of the Built Environment Green Week Debate at UTS – Urban Farms and Green Roofs are just Eco-bling

The Team from Design Architecture and Building (Sumita Ghosh, James Stuart and Sara Wilkinson) won the Green Week Debate – arguing for Urban Farms and Green Roofs. They are the first staff team ever to win and the first team to win debating the negative proposition. It may have helped that they took in lettuces picked that morning from a UTS rooftop garden and a tray of succulent plants from an experiment on thermal performance of green roofs.

### UTS Research and Excellence through Collaboration Award

Associate Professor Sara Wilkinson was one of five UTS academics nominated for a 2015 UTS Research Excellence through Collaboration Award. This is awarded to a UTS researcher, or team of UTS researchers, who have developed and sustained а research partnership and delivered outcomes. was nominated for her work on green roof retrofit. The ensuing collaborations have seen Sara work on four funded research projects with multiple outputs, and joint grant applications with contributions from 17 academics from 17 different discipline areas, from three continents and from ten different universities.

Wilkinson's demonstrated expertise in Green Roofs and sustainable building adaptation and her professional body membership has resulted in the preparation and co-authorship of a forthcoming RICS *Best Practice Guidance Note on Green Roofs and Green Walls*. In this project she worked with two engineers from Arup, three Chartered Surveyors and a Green Roof Installer. This project has enabled her to



apply the research she has been involved in directly to the benefit of practitioners. This guide (due late 2015) will be published for RICS 140,000 members globally.

### Land Tax in Australia, Fiscal reform of subnational government

A new book, published by Taylor and Francis, Land Tax in Australia is due to be released in January 2016. The book demonstrates how land tax operates and is administered across State and local governments in Australia. International expert Vincent Mangioni reviews the current status and emerging trends in these taxes in Australia and compares them with the UK, USA, Canada, Denmark and New Zealand.
